



## SCHEDULE OF RATES Effective January 1, 2022

It is High Ridge House's policy that Christian Science nursing care is available to an individual relying on Christian Science treatment without regard to their financial status. We believe and it is our practice that cost of care should not be an obstacle to admission to our facility. We work with patients to apply for financial assistance to our Benevolence Fund and other Christian Science philanthropic organizations.

### **Christian Science Nursing Care** — including private room, board, and supplies

**Rate 1            \$310/day**

*For patients mostly independent, but requiring some assistance with daily activities. Christian Science nurses on hand to monitor their needs and provide spiritual support and encouragement throughout.*

**Rate 2            \$510/day**

*For patients requiring Christian Science nursing care which cannot be adequately provided by themselves or others at home. The Christian Science nurses also provide consistent spiritual support and encouragement throughout.*

**Rate 3            \$710/day**

*For patients requiring skilled Christian Science nursing care. Consistent spiritual support and encouragement is provided throughout. Care and/or oversight is given by a highly skilled Christian Science nurse. This level of care may qualify for Medicare reimbursement.*

**Rate 4            \$910/day**

*For patients with fluctuating needs requiring highly skilled Christian Science nursing care. Consistent spiritual support and encouragement is provided throughout. This level of care qualifies for Medicare reimbursement, if other Medicare requirements are met.*

**Rate 5            \$ 1,110/day**

*For patients requiring continuous attention day and night from highly skilled Christian Science nurses. Consistent spiritual support and encouragement is provided throughout. This level of care qualifies for Medicare reimbursement, if other Medicare requirements are met.*

### **Medicare Deductible and Co-Insurance**

In 2022, patients whose condition or nursing need meets the eligibility requirements for Medicare reimbursement must pay a deductible of \$1,408 for the first 60 days of covered care. If that patient continues to be eligible for Medicare coverage from the 61<sup>st</sup> day up to the 90<sup>th</sup> day, they will be asked to pay coinsurance of \$352 *per day*. Lifetime reserve days (for days 91-150) require coinsurance of \$704 *per day*.

## **Other Services available from High Ridge House**

### **Visiting Christian Science Nurse Service**

\$72/hr (plus transportation charges based upon location, including parking fees, if applicable)

(For Initial Visit: One hour minimum; travel time to/from patient complimentary)

### **Outpatient Christian Science Nursing Service**

\$72/hr (plus supplies)

**Rest and Study** – Private half-bath, shared tub/shower, queen or two twin beds, includes breakfast. (Lunch and dinner may be added for \$10 each.)

Single \$120/night

Double \$130/night

Special rates available to those attending Christian Science class instruction or association.

**Day Guest** may stay from 9am – 5pm for \$60/day, which includes the use of Rest and Study room as available, study room, scheduled activities (if desired), and lunch.

***Journal-listed Christian Science practitioners and all Christian Science nurses*** (whether or not *Journal-listed*) are invited to spend up to two complimentary nights each year at High Ridge House on a space available basis.

**High Ridge House Board & Staff** are entitled to two complimentary nights each year.
